Simple Fund has 5 modules that significantly reduce processing time and can reduce compliance costs by 30-40%.

Audit Workpapers provides a full set of electronic audit working papers including planning documents, procedure workpapers, engagement and trustee representation letters, a bank audit certificate and a compliance checklist.

Multi Fund Processing enables you to import or export data, create entries, print reports or complete corporate actions (such as ASX code changes, bonus issues, calls on shares, company mergers, dividend re-investments, returns of capital, rights issues, share splits and consolidation) across multiple funds.

FundNet provides you with the ability to view financial, investment and member reports in a browser over the Internet or via an intranet.

Fee Generation provides you with the ability to automatically generate fees and fee invoices based on member balances or asset values across multiple funds.

Members 100+ allows users to have up to 770 members in a single fund (Simple Fund standard is limited to 98 members per fund).
